2025 Crop Storage and Drying Rates

Mendota, Van Orin, and Triumph Locations

Storage Rates:

- ◇ **Corn: 21 cents/bu.** until January 1st, then 4 cents/month charged on a daily basis
- ◇ **Soybeans: 23 cents/bu.** until January 1st, then 5 cents/month charged on a daily basis

Price Later Rates:

- ◇ **Corn: 19 cents/bu.** until January 1st, then 4 cents/month charged on a daily basis
- ◇ **Soybeans: 21 cents/bu.** until January 1st, then 5 cents/month charged on a daily basis
 - Price Later Rates subject to change
 - A 10 day grace period will be allowed prior to applying Storage and Price Later charges.
 - Unsettled grain minimum storage and drying and minimum price later rate will be invoiced and due on January 20th.

Shrink Factor:

- ◇ **Corn:** will be shrunk to 14% for stored and price later corn and to 15% for priced corn at 1.4% per point of moisture.
- ◇ **Soybeans:** will be shrunk to 13% moisture at a rate of 1.5% per half point of moisture. Beans with moisture above 15% will be shrunk at a rate of 2% per half point of moisture.

Storage Rates:

- ◇ **Corn: 21 cents/bu.** until January 1st, then 4 cents/month charged on a daily basis
